# **Administration**

- Parental Consent forms and cheques for £36.50 payable to "Whitstable Yacht Club". should be returned to Whitstable Junior School in the first instance for collation. The forms will be passed on to WYC Training.
- For a child to participate their parent is expected to respond to the weekly confirmation request sent by the WYC Training Manager.
- Club kit (wetsuits, buoyancy aids etc.) will be available.
- Parents are expected to check sailing kit issued to their child on signing in and returning the items washed in tap water at the end of each session before signing out. Changing rooms and showers are available.
- The meeting for each session will take place at the top of the club ramp at 16.30 on Thursdays.

# Parents

- Parents are entirely responsible for the participation of their child / children
- This includes check-in at 4.30 pm and check-out at 6.30 pm with the registrar with collection and return of club sailing kit at each session.
- Please adhere to social distance restrictions while remaining present near the club during a session.

#### Health protocol

- In the event of anyone at home having a raised temperature or a new, persistent cough or any loss of the sense of smell or taste, please do not attend sessions until clear from the risk of infection
- Please note that we will keep records of all participants and parents at sessions in the event of trace and test requirements

# **Conditions of participation**

- 1. Whitstable Yacht Club reserves the right, at all times, to cancel sessions at our discretion, due to weather.
- 2. Whitstable Junior School participants will be in years 5 and 6, wear a buoyancy aid and be confident in the water.
- 3. All children must be accompanied by a parent or guardian to sign in at the beginning and out at end of the session. Parents are entirely responsible for their children's sailing, for attending to any injuries sustained, damage or loss.
- 4. Neither WYC nor any of its employees or agents shall be liable in any way whatsoever in respect of loss or damage to property.
- 5. Whitstable Yacht Club must be informed, of any medical condition affecting the participant, or of any medication taken by the participant that could affect their taking part in the above sailing session, e.g. asthma, epilepsy, heart conditions or covid-19 contact.
- 6. Participants are asked to respect the equipment provided; compensation will be sought from anyone deliberately causing damage to equipment.
